- 1.a. The purpose of this document is to communicate the Policy of ISONIKE for the Use of Certification Marks and Logos as well as the Accreditation Body's Accreditation Marks.
- 1.b. All ISONIKE Certified Organisations and Partners are required to review and comply with the present policy.
- 1.c. Upon the successful completion of the certification process, the Certified Organisations may download the ISONIKE Marks and Logos free of charge from ISONIKE's shared resources or can be send upon request.

Governing Principles on the Use of Accreditation Marks, Certification Marks and Logos.

The client shall:

- Use the ESYD Accreditation Mark only when it appears on the certificate. When doing so, use the mark in accordance with ESYD "Regulation for the Use of the National Accreditation Logo" that can be found on ESYD webpage www.esyd.gr.
- Use the ISONIKE Certification Mark and ISONIKE Certification Standard Logos that appear on the certificate or approved by ISONIKE.
- Use the marks and logos in communication media such as the internet, on promotional materials, correspondence and advertising (see table 1 of previous section).
- When using the ESYD Accreditation Mark, the ISONIKE Certification Mark and the ISONIKE Certification Standard Logos, use
 them within frames and as illustrated in the examples that follows. In all cases the marks and logos shall include underneath:
 - The certificate number (which in turn appears on their certificate) adding the words 'Cert. No' or 'Certification Number' and the digits.
 - The certified management system, placed centrally under the certification.

<u>Note:</u> If the client is certified to more than one management system, those may be listed one under the other, centrally under the certification number, separated by a comma.

- Marks and Logos can be reproduced in full color (as specified in the Color Palettes that follow), or black and white, or grey.
- The Marks and Logos shall not be altered or modified. They may be resized, provided that the proportions of the marks and logos are maintained and all features are clearly distinguishable. If the marks and logo includes an accreditation number, the number shall not be removed from the logo.
- The term Accredited shall not be used when referring to certificates issued by ISONIKE, as this term refers to the accreditation
 process by the Accreditation Bodies (e.g. ESYD). Clients certified by ISONIKE are referred to as Certified Organisations and
 hence not Accredited by ISONIKE.
- Use the Marks and Logos as per illustrated examples that follow.

5. Restriction on the Use of Certification and Accreditation Mark and Logos.

- 5.a. If the scope of certification does not include all the products or services provided by the certified client, the logo shall not be used in a way implying that all the products or services of the organization are covered by the scope of certification.
- 5.b. A management system certification mark or logo shall not be affixed to a product nor product packaging nor used in any other misleading way that might suggest product, process or service certification. The mark and logos apply only to management system certification.
- 5.c. Any reference to the certification of a management system shall include: a) reference to the management system standard, b) reference to the certification body ISONIKE, c) reference to the certified client d) reference to the certificate number.
- 5.d. Not allow reference to its management system certification to be used in such a way as to imply that the Certification Body ISONIKE nor the Accreditation Body certifies a product (including service) or process.
- 5.e. If the scope of the certification does not include all the locations or facilities of the certified client, the logo shall not be used in a way misleading that all locations/facilities of the organization are covered by the scope of certification.
- 5.f. There shall be no ambiguity in the logo or the accompanying text, as to what has been certified and which certification body has granted the certification.
- 5.g. The logo shall not be used to laboratory test, calibration or inspection reports or certificates.
- 5.h. The certified client shall not use the certification logo in such a manner that would bring ISONIKE or the Accreditation Body or the certification system into disrepute and lose public trust.
- 5.i. The certified client shall not make or permit any statement regarding its product certification that may be considered to be misleading or unauthorized.
- 5.j. Upon withdrawal or suspension of certification the certified client shall discontinue the use of the logo on all advertising matter that contains reference to certification.
- 5.k. If the scope of the certification has been reduced, the use of the logo shall be amended regarding the new scope of certification.
